

Layaway Policy

Layaway terms are available for merchandise priced at \$200.00 and up. Length of layaway is 90 days from date of purchase.

Any purchases totaling \$200.00 or more is divided in to an equal "three" payment plan 1/3 down (deposit, is NOT refundable), 1/3 in 30 days and the remaining 1/3 in 60 days. The last payment will include S/H fees.

Each payment is due on the same day of each month and is determined by the date the down payment was made. For example, if down payment was paid on the 12th day of the month, then all future payments are due on the 12th day of each month for the course of the layaway.

- Payments made by Check or MO must be received by specified Date.
- Payments made by Credit Card will automatically be charged on specified Date.

If monthly payment is more than 5 days late, a \$5.00 late fee will be added to layaway balance.

If more than 60 days lapse between payments, then the merchandise will be removed from layaway and all funds will be forfeited.

If customer cancels layaway at ANY time, the 1/3 down deposit will be forfeited.

The terms of this policy may change at any time. The policy in effect at the time you make your down payment will govern your layaway.
